
I would like to thank all of our members that volunteered and worked our booth at this year's Autorama. We had a great display set up this year.

<u>APBA News</u> (Mark Weber): Dayton Testing is on schedule (Think Spring). All classes are invited. There has been a change in Hotels for this year. IRC Racing News (Marty Hammersmith): No report

Region 6 News (Eli Whitney): Eli thanked all of those who attended. There were seventy three (73) people who attended the banquet. This helps keep the banquet, and meeting room use, on track at this facility.

Eleven (11) people took the Assistant Risk Manager Test.

In-Board By-Law changes were approved as follows:

- National High Points will be awarded to Owners who are residents within the boundaries of, or assigned to, Region 6.
- Helmets approved for racing will be Snell 2000 Minimum.

Ray Dong commented on the completion of the ceramic coating added to the Official Race Timing Clock by Mark Tate. This clock has been in existence for thirty (30) years, and even went swimming one (1) time in Sylvan Lake. With this coating, and a little care in handling, this clock is expected to live another thirty (30) years. Thank you to Mark Tate for your effort in making this asset a working legend.

<u>Vintage Report</u> (Jeff Sutton/Jack Hines): Jeff Corrigan has his Vintage boat at John Jenkins shop for a major reconstruction. The boat has been stripped to its bare bones, and is not expected to be completed this year. Steve Phillips (flat bottoms) has a conglomerate of race motors for sale. John Bridge II, and Chris Ritz, invited him to pay his Marine Prop Riders Membership dues, and in return, we would be glad to run an on-going classified section to help him sell his menagerie of race motors and parts.

Old Business: Autorama is once again upon us, and I would plead for volunteers, but just as last month, you will get this notice, in the newsletter, long after the event has taken place. The Demographics of this show is right for our club, therefore our efforts to show boats, and advertise the club, are best placed at this show. Thanks again to Rich Falcinelli for his efforts in coordinating boats, and volunteers at this show! Thanks to Tim Sutton, Jack Hines, Paul Poledink, Kent Keogh and their Crews for making their boats available at this show!

New Business: The display boat is not available for the Autorama, and needs some attention soon if it will be available at all this summer. It was suggested that a date be picked, and a volunteer work party be made, to get this boat prepared for paint. Stickers can be removed, and it could be repaired and sanded in preparation for the paint in which the Washtenaw Community College has volunteered to spray for us. A "wrap" was suggested, but the current surface will still need to be restored, and the "wrap" would cost about fifteen (\$1500.00) hundred dollars. The boat is currently in Bartush's shop located in downtown Detroit. Chris Ritz and Mr. Wilson will coordinate the work party. An E-mail will be sent out to notify those who might be interested in joining in on the work party.

Earl Stilson and Kathy Shuler are heavily involved in a program with "Veterans Returning Home". This is a Michigan based non-profit organization that is a transitional facility for homeless Veterans. Sandy Bower, the founder, has purchased the building (old Red Cross building) at I-696 and Gratiot in Roseville, Mi. The building is a fifty (53) three room facility in which the founder has completely funded on her own for one (1) year until she received her non-profit 501(C)3 status last December. Now she has the opportunity as a non-profit organization to raise funds to continue to support her mission in transitioning homeless veterans to active, participating members in society.

There will be a fund raiser on March 28, 2015 at the Royalty House. The address for the Royalty House is; 8201 E. Thirteen Mile Road, Warren, MI 48093. One Hundred (100%) percent of all ticket sales, donations, and raffle proceeds will go directly to the Veteran facility. Vintage Views

The Big Brown Speedboat on the Wall

As part of our annual wedding anniversary remembrance, my wife Alice and I go out for dinner, and for the past several years we have gone to the **Bayside Sports Bar and Grill.** The food is excellent, and I always make it known to the manager on duty that we appreciate their sponsoring of the summer hydroplane races. And, that patronizing **Bayside** is a concrete way of showing our appreciation. We decided to go home to South Lyon after a recent dinner a different way, by going north on Pontiac Trail and turning left on Maple Road.

Right on the southwest corner is a Murray's Auto Parts store, and on the store's large sidewall wall - to my surprise - was a mural of a vintage triple cockpit runabout with a happy couple in each set of seats. The mural invited the viewer to go to Walled Lake Park, the Picnic Wonderland. In the background was a roller coaster and Ferris wheel. OK, cool. But, there is no Walled Lake Park - at present. There WAS a Walled Lake Park which I went to as a kid, but I vaguely remembered that it closed down a long time ago, in the 50's or 60's. So what was this mural promoting? Time for some historical detective work.

Good ol' internet search engine came through. I entered in some key words, and verified that there was of course a Walled Lake Amusement Park, which was operational from 1919 through 1968. It had a dance hall, the Casino, a world class roller coaster, a picnic area, all sorts of amusement park rides, and some water/beach attractions. It was located on the south end of Walled Lake, to take advantage of a natural swimming area, and then in one paragraph of the article I was reading, there it was, buried at the end of a listing of Park attractions, ". . .and speed boat rides for fifteen cents."

Another reference revealed that "Extending out from the point were two 500 ft. boardwalks where thrill seekers could get a speed boat ride for 15 cents." A third writer thought that the speed boats were "criscrafts." So that's what the mural was promoting, these speed boat rides and picnicking. But . . . the mural was not old and faded; it was fresh and vibrant and, well, sort of retro-modern. What's the story here?

Another internet search found a local November 2011 newspaper headline stating "Murray's Gets Historic Mural." And, according to the newspaper account, the mural was partially supported by the Walled Lake Downtown Development Authority and a Federal Facade and Sign Grant, to replicate a popular poster of the old park.

At this point, I thought it would be interesting to talk to the owner of the Murray's to get a feel for his reasons for placing the mural on his building. The owner, Karl Blair, now retired, met with me for a half hour or so and gave his side of the story. He said he looked at the vast expanse of blank wall facing Maple Road as a location for some auto parts store type of advertising signage, but was told by the city that he couldn't use it for this purpose. Not giving up, Karl suggested the placing of some sort of community spirit message on the wall. How did he come up with the boat mural? It came to him, he said, after reviewing some local historical pictures, postcards, and posters at the Walled Lake City Hall. And, he stated that he bore much of the cost of the painting of the mural himself – and, that it wasn't cheap.

Who painted the big brown boat mural? Peter Flores, a commercial sign painter from Dearborn, who had a contract to paint the signs for many of the Murray's Auto Parts stores, now absorbed by O'Reilly Auto Parts to a great extent. Peter related that it took him about two weeks to paint the mural to the wall, and that he copied the theme from an old poster picture given to him by Karl.

Aside from the grandeur of this mural, my disappointment in this search was that although I found many photos of the Park and its attractions in its heyday, there were no actual pictures of the thrilling "criscraft" speedboats. I'm guessing that although WE like to think that driving or riding in any fast boat is beyond description, the operators of the park and attendees were more enthralled by the conventional rides - the Green Dragon Roller Coaster, the Tilt - a-Whirl, the Dodge'em Cars, and so on. The references state that many of the rides at the park were sold to other amusement parks when Walled Lake Park closed – the Roller coaster was demolished, and the Casino dance hall eventually burned down— but what happened to the boats? And, is this big brown boat in the mural an accurate rendition of a Chris Craft triple cockpit speedboat? Is there any meaning to the three stars on the burgee? Who drove and maintained these boats?

And finally, did the people who went for these \$.15 thrill rides have to sign a waiver? Get a wrist band? Or wear a life vest or PFD, or orange helmet? Wear closed toed shoes? Driver have a physical? Boats inspected? Don't think so.

Life was simpler then, I suppose. More carefree, but probably more dangerous. Those good ol' days that many older folks refer to. But, were they truly better? The couples in the big brown "criscraft" triple cockpit sure look pretty happy.

Power boat racing is a sport. As fun as it is, participation in any sport, let alone one that includes maneuvering a 1500 pound projectile at speeds in excess of 100 mph comes with some risk. Every year racers from all over the country suffer a suspected head injury. Racers can sustain a head injury in incidents such as blow overs, barrel rolls, wing outs, collisions, stuffs, cartwheels, hard landings or any combination of these.

WHAT IS A CONCUSSION?



A concussion is a form of Traumatic Brain Injury (TBI) which disrupts the way your brain functions. The kinetic energy, momentum and velocity or violent shaking of the head forces the brain to slam against the inside of the skull causing injury and swelling. The head injury can also cause tearing of blood vessels, injury to nerves and can cause chemical changes making the brain more sensitive until it recovers. During a heat, the racer's head is rotated in all directions watching the course and other boats. A sudden acceleration and / or deceleration combined with rotation and flexation makes the racer even more vulnerable to injury.

CONCUSSION FACTS



- · All concussions are serious.
- · A concussion cannot be seen.
- All suspected head injuries should be evaluated by emergency personnel.
- Not all concussions result in a loss of consciousness.
- Not all concussions are alike. They will affect each racer differently.
- A racer may have a concussion and not realize it.
- Never ignore a possible concussion.
 Even though it may appear normal at first, it could take hours, days or even weeks before the full extent of the injury is known.
- Recognizing a possible concussion and responding properly when they first occur can help prevent further injury. When treated correctly, most concussions heal. Left untreated, a concussion can result in permanent damage and worse, can even be fatal.



- Repetitive brain injuries, when not managed promptly and properly, or permitted time to heal, can slow recovery and may cause permanent damage to your brain.
- Racers who have had a concussion at any point in their lives, have a greater chance of getting another concussion.

WHY REPORT IT?

 Besides all of the reasons already mentioned, it is your brain that controls all of your body's systems.







The one thing that controls your judgement, hand-eye coordination, vision, response times, and every one of the skills you use as a driver is now in need of repair.

The racing community prides itself on being close. You all do your best in the pits to help each other to get back out in the water. If there is a broken part, you fix it.

Sometimes racers need repairs too! What if that racer with a suspected concussion goes back out and is seriously injured? Or injures another racer, possibly a close friend or family member of yours. That racer knowingly went back out putting fellow racers in jeapordy because they ignored, didn't recognize or are too macho to admit their skills may not be up to par.

Risking the safety of others is NOT their decision to make. Fellow racers, crew members, officials and rescue all must share the responsibility for keeping the sport as safe as possible.

Be that role model everyone thinks you are. When in doubt... Sit it out!

Any racer who recieved a blow to the head or any significant acceleration / deceleration type force to the head should be presumed to have a possible head injury and should be thoroughly evaluated.

To help recognize a concussion, you should watch for and ask others to report two things:

- A forceful bump, blow or jolt to the head or body that results in rapid mocement of the head.
- Any concussion symptoms or change in behavior, thinking or physical functioning.

SIGNS & SYMPTOMS

- · There is no single indicator for a concussion.
- Please indicate which signs and symptoms were observed.
- Headahce or "Pressure" in head
- Confusion or Disorientation
- Dazed or Stunned
- Moves Clumbsily
- Concentration issues
- Loss of consciousness (even briefly).
- Mood, personality or behavior changes
 Ringing in the ears
- Memory problems / Amnesia
- Double or Blurry vision
- May experience balance problems

- Slow reaction time
- Can't recall events PRIOR to incident
- Can't recall events AFTER incident
- Vomiting and / or Nausea
- Complaints of tiredness
- 🐞 Feeling sluggish, hazy, foggy or groggy 🧥 Neck pain
- Forgets instructions
- Dizziness
- Saw all white, all black or stars

- Signs & Symptoms generally show up soon after the injury.
- Some may be delayed and take hours or days to present.
- Signs may be observed by others.
- Racers may report experiencing symptoms
 - Saw flashing lights
 - Answers questions slowly
 - Sensitivity to light
 - Sensitivity to noise
 - Just "not feeling right"

 - Feeling having lost time
 - Sleep disturbances
 - Other signs that feel worrisome
 - Unusual behavior



- Fluid / blood leaking from ears / nose
- Change in consciousness or alertness
- One pupil larger than the other
- Slurred or incoherent speech
- Weakness, numbness, decreased coordnination
- Unusual eye movements
- Inability to wake up
- Fever
- Symptoms that worsen

If the following danger / warning signs present, call 9-1-1 and take the injured immediately to the emergency departent.



GETTING BETTER

- Most people with a concussion recover quickly and fully
- Some signs and symptoms can last for days, weeks or longer
- · Exercising or activities requiring a lot of concentration such as working on a computer may cause symptoms to reappear or
- After a concussion, physical AND cognitive activities should be managed and monitored by a healthcare professional.
- It is normal for a racer to feel frustrated, sad and even angry because they cannot return to competition right away or with daily activities. Talk with them about these issues and offer support and encouragement.
- Healing and recovery will take some time. Do not rush it.


